### NATURE OF THE BUDGET REVISION

1. This budget revision (BR) of the Cuba development project (DEV) 105890 "Support to the National Plan for the Prevention and Control of Anaemia in the Five Eastern Provinces of Cuba" is requested in order to: Increase the overall budget; replace the distribution of CSB with MNPs for children in the age group of 6 to 35 months; and include children in the age group 36 to 59 months to be assisted with imported Super Cereal (CSB+).

- 2. The revision will enable WFP to continue providing assistance to address anaemia which is a public health priority in the eastern region of the country, owing to the high anaemia prevalence of 39.5 percent in children between 6 to 23 months and 17 percent in the group of children between 24 to 59 months.
- 3. The proposed budget revision results in a total budgetary increase of US\$313,773 due to:
  - Increase of food requirements by 12 mt, while decreasing Super Cereal by 127 mt for a total net increase in food costs of US\$201,765; and
  - ▶ Increase capacity development and augmentation activities by US\$91,480.

# JUSTIFICATION FOR BUDGET INCREASE

## Summary of existing project activities

- 4. The project focuses its activities on the five eastern provinces of Cuba (Guantánamo, Santiago de Cuba, Granma, Holguín and Las Tunas) in support of the National Plan for the Prevention and Control of Anaemia. This programme aims to reduce the prevalence of anaemia among children under five and to support the achievement of the MDG target of reducing the prevalence of anaemia to 15 percent by 2015. WFP and the Government of Cuba have agreed on a two-track strategy:
  - Provision of Super Cereal (iron-rich food) and MNP by WFP complemented with a multistakeholder social communications campaign.
  - Increase efforts to enhance local production capacity of Super Cereal in order to improve household access to an affordable food basket. This includes establishing production of the commodity, improving household consumption patterns, enhancing food and nutritional surveillance, building national logistics capacity and supporting the phase-out of WFP assistance.
- 5. The approach of the operation involves training and communication in nutrition, including development of an integrated plan by the Ministry of Public Health, Federation of Cuban Women (Federacion de Mujeres Cubanas –FMC), UNICEF, the Pan-American Health Organization (PAHO) and WFP for a social communications campaign aimed at mothers, health workers and food distribution personnel. The campaign will include monitoring and evaluation (M&E) by the National Centre for Health Promotion and Education (CNPES) to assess progress.

## Purpose the budget increase

- 6. MNPs will continue to be distributed to children in three of the five eastern provinces as per budget revision 07 and will be expanded to cover the remaining two provinces. Through this budget revision, MNPs will be distributed to all children aged 6 to 35 months within the project.
- 7. Super Cereal will be distributed to children 36 to 59 months of age in the five eastern provinces. The original project planned to support this group, but this had previously not been possible due to lack of funding. Anaemia is still a health problem among this age group which does not receive complementary fortified foods subsidized by the government. According to research recently published by the Institute of Nutrition and Food Hygiene (INHA), less than 5 percent of children in

this age group consume fortified blended food, mainly due to lack of access<sup>1</sup>. Super Cereal serves as a vehicle for iron, but also helps to diversify the complementary feeding of young children.

- Given current capacity limitations in local production, WFP will import Super Cereal. However, 8. taking into account that one of the objectives of the National Plan for the Prevention and Control of Anaemia is to ensure the local availability, access and consumption of a fortified cereal for the population at risk, WFP will continue working with the government and supplier to augment existing production capacity and identify alternatives
- 9. While working on strengthening the local capacity to produce Super Cereal, significant emphasis will be given to activities aimed at strengthening institutional capacities through training of health practitioners and the reinforcement of the Nutritional Surveillance System (known locally as SISVAN). These efforts will pave the way for WFP's new strategy for Cuba, which will be implemented through the Country Programme currently under formulation and due to start in 2015.
- 10. WFP new strategic approach was developed to effectively address the changes Cuba is undergoing and to reflect the current operational constraints. Extensive economic reforms in 2012 have led to significant changes in government priorities in terms of social programmes, with a potential impact on the food security of vulnerable groups in Cuba.

### FOOD REQUIREMENTS

- 12. MNPs will be provided to children 6-35 months of age and Super Cereal to children 36-59 months of age in the five provinces. MNPs will be procured internationally. The internal transportation costs of the MNPs will be covered by the government as is currently the case with Super Cereal.
- *13.* Rations remain as per previous BRs with 60 MNP sachets provided semi-annually to children aged 6 to 35 months and a daily ration of 50g of Super Cereal for children 36 to 59 months.
