NATURE OF THE INCREASE

- 1. This budget revision to Burkina Faso PRRO 200509 (PRRO) proposes a technical adjustment to reflect changes in the external transport budget due to the unplanned airlift of 217 mt of Plumpy'Sup.
- 2. In late September 2013, WFP executive management released funds to programme 217 mt of Plumpy'Sup with a best used before date of November 2013 for immediate distribution in Burkina Faso. The stock in Dubai valued at US\$700,000 would have been a loss to the forward purchase facility (FPF) programme if not transported to a WFP operation for immediate distribution.
- 3. Analysis of the Burkina Faso pipeline showed a need for Plumpy'Sup to supply PRRO blanket feeding and distributions in health centres across the country. Given the urgency of the stock expiration, it was decided to airlift the commodity from Dubai to Ouagadougou.

JUSTIFICATION FOR BUDGET INCREASE

Summary of existing project activities

- 4. The PRRO aims to reduce acute malnutrition and increase food security by strengthening the capacity of households to withstand shocks. It supports WFP 2008–2013 Strategic Objectives 1, 2, 3 and 5 and contributes to Millennium Development Goals (MDGs) 1, 4, 5 and 7. The PRRO has these activities:
 - Improve the nutrition status of malnourished children aged 6–59 months and malnourished pregnant and lactating women through the prevention and treatment of moderate acute malnutrition (Strategic Objective 1);
 - Improve retention of children with severe acute malnutrition at in-patient treatment centres by providing food rations to caretakers (Strategic Objective 1);
 - Strengthen the resilience of households and communities to withstand shocks through asset creation in support of agricultural livelihoods (Strategic Objective 2);
 - Restore and rebuild the livelihoods of temporarily food-insecure households recovering from shocks (Strategic Objective 3) and;
 - Reinforce national capacities to tackle food insecurity and malnutrition, for a gradual handover of activities to local and national authorities (Strategic Objective 5).

Purpose of the budget increase

5. The cost of airlifting 217 mt of Plumpy'Sup at an air transport rate of US\$3,274 per mt was significantly higher than the initially budgeted cost for shipping by sea. The additional cost is justified to meet the challenge of using the commodity before its expiration date.
